## University Introduction

## Fee Information



<b>Application Fee</b>	500 RMB per person
<b>Tuition Fee</b>	Full tuition funding is provided
<b>Accommodation Fee</b>	Free on-campus accommodation is provided
<b>Medical Insurance Fee</b>	International student medical insurance in China will be purchased uniformly for students
<b>Living Expense</b>	A certain amount of living allowance is provided
<b>Other Fees</b>	International travel expenses, visa processing fees and other related expenses shall be borne by students themselves

- Notes:** (1) The actual number of funded places for the program is subject to the approval of the China Scholarship Council.
- (2) If the applicant does not receive funding from the China Scholarship Council, he/she shall pay the relevant fees for the program study, which is 3,000 RMB per person (including application fee, tuition fee and accommodation fee). The applicant shall purchase international student medical insurance in China at his/her own expense.
