Dear Sue

First of all, my congratulations on your election as Chancellor of the University of Canterbury. Your election and the appointment of Professor Cheryl de la Rey as Vice Chancellor has created a historic first for the University, with both leadership roles occupied by women.

I am pleased to reappoint you as a council member for a term from 1 August 2019 to 31 May 2021, the maximum under the University's constitution. To accept the appointment, you need to complete the enclosed form that provides your consent and asks you about any potential conflicts of interest. Please return the signed form to the Tertiary Education Commission and provide a copy to the Registrar of the University of Canterbury.

Your role on the council requires an ability to balance institutional autonomy with public accountability and compliance requirements. This is reflected in the Education Act 1989 (s176A), which sets out your individual responsibilities as a council member and your fiduciary duty to the institution and its stakeholders. I also attach a summary of my expectations, as Minister, around how you discharge those responsibilities.

Education has the power to change lives and underpins the innovation and creativity that is vital to the future of New Zealand. The aim of this Government is that all New Zealanders are equipped to be successful in the 21st century, with the transferable knowledge and skills to enable them to take on different types of work throughout their careers.

Achieving those goals is not straightforward and all tertiary education institutions are facing the challenges of a rapidly changing environment. This places even greater emphasis on good governance and the need for the University Council to guide the institution through those challenges, determining strategic direction and evaluating progress against agreed goals.

Thank you for continuing to contribute your valuable skills and experience to the work of the council and for being available for election as Chancellor.

Subject:	ELECTION OF PRO-CHANCELLOR	

Council approved a process for the election of Chancellor and Pro-Chancellor at its meeting in September 2015 (attached).

In accordance with that procedure, nominations were invited for Pro-Chancellor on 10 December with two nominations having been received:

- Shayne Te Aika
- Steve Wakefield

Further nominations can be accepted up to the time of the Council meeting on 30 January 2019 at which time the election will take place.

As Mr Te Aika is unable to attend that meeting, I recommend that no candidates be invited to speak, however candidate statements are attached from each of the nominees.

### Procedures for elections of Chancellor and Pro-Chancellor

- 1. The Registrar of the University is the returning officer for the election of Chancellor and Pro-Chancellor.
- 2. The Registrar will notify Council members of a forthcoming election for Chancellor or Pro-Chancellor at least one Council meeting prior to that at which the election will take place. The notification will normally be in writing contained in the papers for the prior meeting, and also orally at the prior meeting.
- 3. (a) Nominations for the positions may only be made by Council members.

(b) Nominations may be made by written notice received by the Registrar at any time before the commencement of the meeting at which the election is to be held, or orally at that meeting.

- (c) To be valid a nomination must be accepted by the person nominated.
- 4. The Registrar will take the chair for that part of the meeting during which the election is to be held.
- 5. The Registrar may request the nominee or nominees to leave the meeting if their presence might impede free and frank discussion.
- 6. If there is only one person nominated for a position the Registrar will declare that person elected.
- 7. (a) If there is more than one person nominated for a position there will be an election by voting. All members of Council, including the nominees, are entitled to vote.
  - (b) If any member of Council requests a secret ballot, Council members will give their votes in writing to the Registrar. If there is no such request, the vote will be by show of hands. The nominee with the highest number of votes will be declared elected.
  - (c) In the event of a tie the election will be decided by the Registrar by lot.
- 8. In any particular case all or any of these rules may be suspended by majority vote of the Council and replaced by such procedure as it thinks fit.
