## Career planning: what do I need to know?

Knowledge of yourself is important for career decision making. Start by looking at your personal goals, abilities, values and interests to explore study and career options that are relevant to you. Some of these may change over time, so it is important to self-reflect and evaluate your career on an ongoing basis.

#### What do employers look for?

Many employers look for generic skills such as communication, customer-focus, bicultural competence, cultural awareness and teamwork. With technology and globalisation changing the nature of society, skills such as resilience, problem solving and adaptability are valuable at work as well as in life.

#### How can I develop these skills?

• Some skills are developed through your degree

- Extra-curricular activities can help, for example getting involved in clubs, mentoring, cultural groups, part-time work or volunteering
- Be open to professional and personal development opportunities. Whether it is undertaking an internship, study abroad, skills seminar, or joining an industry group — these activities will enhance your employability.

# What is Taxation and Accounting?

Taxation is much more than interpreting and applying legislation. Societies need taxation in order to redistribute wealth, to provide for expenditure on public goods and services, as well as serve as a tool to influence behaviour.

Taxation is a core area within accounting and law, drawing together concepts from these disciplines, with those from economics. Knowledge and theories in other fields, such as history, psychology and sociology, are applied to help understand the impact of taxation on society.

Chartered Accountants Australia and New Zealand, and CPA Australia include taxation courses in their 'core' and 'accounting and/or business-related' academic requirements.

## What jobs and activities do graduates do?

Graduates with this degree are employed in a range of jobs — see some examples below.

#### Tax consultant

- Engages in tax planning and transaction structuring
- · Provides advice about tax obligations
- · Ensures tax laws are complied with
- Advises large enterprises on cross-border tax issues

#### Accountant

- Manages the flow of money through an organisation
- Reviews and analyses the performance of businesses, governments and other entities
- Provides financial advice to managers, entrepreneurs, business clients and governmental bodies

#### Financial controller, finance manager

- · Manages the finance team
- Oversees financial accounting and management reporting
- Analyses performance against objectives and recommendations for improvement

#### Business analyst / consultant

- Generates financial and other information
- Reports on organisations, projects, contracts
- Analyses economic and business trends to inform decisions and protect interests

#### Auditor, audit analyst

- Examines financial statements
- Provides evidence as to the accuracy of these
- Checks the legality of funding use

#### Forensic accountant

- · Examines illegal financial activity
- Analyses financial information and data for evidence
- · Acts as an expert witness

#### Internal auditor

- · Carries out audits of systems
- Advises management of the strength and reliability of internal controls
- · Reports to the board of directors

#### Tax auditor

- · Examines financial statements and tax returns
- Undertakes investigations and reviews
- Ensures tax deductions, income and credits are accurate and lawful

#### Interest rate risk manager

- · Helps clients to manage their interest rate risk
- Tailors solutions to meet client needs and goals
- Uses market insight and risk management strategies

#### Entrepreneur

Through generating a business idea, or getting involved in a start-up/business venture, you have the potential to create a work opportunity that aligns with your knowledge, skills, values and risk profile. ## Why should a student at UC consider a career in tax?

The public practise of tax provides a great career option for those who like business and enjoy solving problems. Please don't assume a career in tax is just about completing tax returns and compliance processes (as smart software now takes care of the majority of that!). I've found a career in tax to be broad in nature, always changing and something that still regularly presents problems that are not easy to solve.

Being in private practice has also meant that I have been able to apply the discipline to help a range of businesses at all stages of size and complexity. When I say help, that doesn't mean dodge tax. The work we do is

very much focussed on helping our clients meet their compliance obligations through providing certainty often with the help of Inland Revenue through its rulings regime.

### What has your career looked like so far?

I graduated from UC way back in 2003 with conjoint degrees in Law and Commerce. From there, I joined the Tax team at PwC Auckland, where I also studied towards my CA and became admitted to the High Court. PwC also sponsored me to complete a Master in Tax at the University of Auckland which I studied part time while working. In 2007, I jumped at the opportunity to transfer to PwC's New York office where I worked for a couple of years before ultimately ending up back in Christchurch. While I started out as a generalist, I now specialise in international taxation, where I help mainly New Zealand based exporters navigate the tax rules associated with operating cross border.

#### What are your career highlights?

I have had so many fantastic highlights over the years and I am massively thankful to PwC for giving me those opportunities. There are so many examples I can think of where we have really made an impact for a client that has helped catapult their business success. Working on such projects alongside the incredible team that is PwC has been immensely rewarding for me. In addition, the opportunity to live and work in New York was definitely a career highlight and I know many of

our team who have also completed international transfers would say the same. Lastly, another massive highlight has been the on-going flexibility that the career in tax and PwC has given me so that I can do big things outside of work (like completing the Coast to Coast in 2019). PwC is ahead of the curve in promoting flexible work practices.

# What advice do you have for someone considering taxation accounting as a career?

Tax is a broad practice area with plenty of opportunities to further your personal and professional goals. My advice is to embrace them, to be determined in growing your technical skills, particularly at the beginning of your career. With time and effort, get to know your clients business and needs. Finally, when given the opportunity to do something new, be it an overseas transfer or a chance to work on something you haven't done before, take it.
