Workload expectations

What does a STAR course involve?

Most of the UC courses that are open to STAR students are 15-point courses run over one semester. Most students would have a workload of on average 8 hours a week, which can include time spent in class, reading the online course materials, working on assignments and preparing for and sitting an exam/test. ECON199 and the distance version of ECON105 are 15-point courses run over the whole year and have a workload of on average 4 hours a week.

Declaration
